Meeting of the Executive Committee November 28, 1983

The purpose of the meeting was to discuss progress and plans in the formation of the System Dynamics Society. The following actions were discussed and approved:

- 1. The treasurer will look into incorporation, insurance, and bonding of the society.
- 2. Letters will be sent to members of the council informing them of progress and providing the minutes of the meeting.
- 3. Letters will be sent to members of the Society informing them of progress.
- 4. Letters will be sent to nonmembers inviting them to join the Society.
- 5. The date of charter membership will be extended from November 1, 1983 to June 1, 1984.
- 6. The Society will obtain its own letterhead for use in correspondence. The letterhead will show the Society's name and list the current officers and policy council members.
- 7. The treasurer will produce a financial report for the Society as of December 31, 1983 and look into investment possibilities for society funds.
- 8. The treasurer will negotiate the balance of the 1983 Conference with the sponsoring group at M.I.T.

- 9. The treasurer will assemble a list of members, working from the 1983 conference file.
- 10. The president will convene a meeting of officers, the policy council and the nominating committee in April or May of 1984 to discuss nominations of officers and policy council members for 1984-1985, and publications.
- 11. The secretary will negotiate the sponsorship of the 1984 conference with conference chairman Jørgen Randers. The Society will aim for a limited financial role in the 1984 conference, guaranteeing losses and receiving profits. The Society will seek an increasing role in the organization of future conferences.
- 12. The secretary will contact the editor of DYNAMICA, Eric Wolstenholme, to initiate discussions on a society publication.
- 13. The president-elect will contact Nathan Forrester about the organization of the 1985 System Dynamics Conference.
